

Observance of Vigilance Awareness Week - 2025

Central Vigilance Commission adopts several strategies for effective implementation of its mandate to fight corruption. Observance of Vigilance awareness Week remains one of the primary tools of preventive vigilance with the focus on building awareness and re-affirming the commitment of everyone to uphold integrity in public governance. Central Vigilance Commission had decided that Vigilance Awareness Week would be observed from 27th October to 2nd November, 2025 on the theme of:

"सतर्कता: हमारी साझा जिम्मेदारी" / "Vigilance: Our Shared Responsibility"

The observance of Vigilance Awareness Week 2025 commenced with taking of the Integrity Pledge in the National Handloom Corporation by the Pledge Taking Ceremony will be held at NHDC Corporate Office on 27-10-2025. All the Officers/Staff of the NHDC Corporate Office assembled in the Hall. The Pledge taking ceremony was held in the presence of CVO. Similarly, the Pledge Taking Ceremony was also held at the Regional Offices of the Corporation and all the officers and staff at the Regional Offices Took the Pledge. 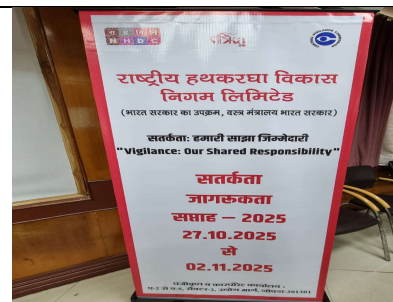

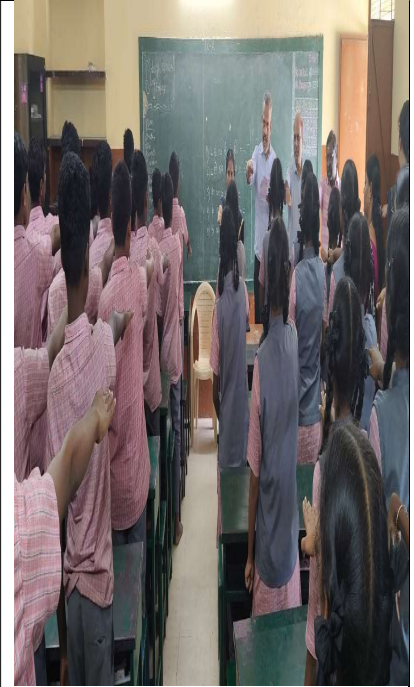

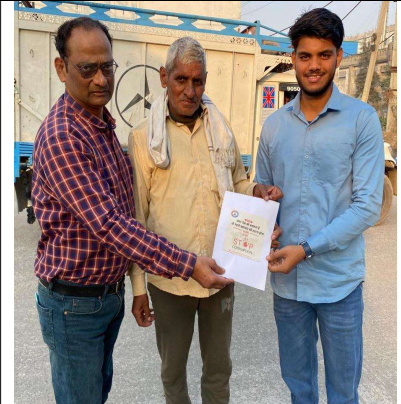
During the Vigilance Awareness Week Regional office – Hyderabad conducted Panel discussion on corruption and preventive vigilance on date 06-11-2025.
